Preschool Admission Agreement

We, the parents/guardians of _____, agree to the following terms and conditions for preschool services:

1. Eligibility

- Our child is aged 2-6 years, making them eligible for preschool.

2. Timings & Late Pickup

- Preschool timing are from 9:00AM - 12:00PM, Monday - Friday.
- A ₹70 per hour late fee applies if the child is picked up more than 15 minutes late.

3. Meals

- We are responsible for sending our child's meals from home, and understand that differing food styles may affect our child's preferences. The preschool is not responsible for any issues arising from this.

4. Pickup & Drop Discipline

- We will ensure our child is dropped off and picked up on time.
- If someone other than us is picking up the child, we will notify the preschool in advance and provide identification.
- A late pickup fee of ₹70 per hour applies.

5. Health & Safety

- We will provide accurate and up-to-date medical records for our child.
- If our child shows any signs of illness, we agree not to send them to school to avoid disrupting the learning environment.

6. Emergency Situations

- We authorize the preschool to contact us and seek medical treatment in case of emergencies. We agree to bear all medical costs.

7. Behavior & Discipline

- We understand that positive behavior is encouraged and the preschool will use age-appropriate methods to manage behavior.
- Disruptive behavior that affects the learning environment will be addressed promptly.
- If misbehavior continues, we agree to cooperate with the preschool in addressing the issue, which may include suspension or termination of services if necessary.

8. Fees & Payments

- Fees are due according to the preschool's payment schedule.
- Fees are non-refundable, and a 10% penalty per month applies if payments are not made on time.

9. Termination of Services

- We will provide 2 weeks' written notice if we wish to withdraw our child.
- If we fail to provide notice, we acknowledge a penalty fee equivalent to the next month's tuition.
- The preschool can terminate services if payments are delayed or if behavior/policy violations persist.

10. Liability Waiver

- We acknowledge that the preschool takes all necessary precautions for our child's safety but is not liable for injuries or unforeseen incidents that may occur during preschool activities.

11. Data Protection

- We consent to the preschool collecting and storing our child's personal and medical information as per data protection regulations. This information will be used only for the purpose of providing care and services.

12. Additional Fees

- We understand that additional fees may apply for special events such as Sports Day, Annual Day, or other extracurricular activities. These fees will be communicated in advance.

13. Photo & Video Consent

- We consent to our child being photographed or recorded during preschool activities for educational or promotional purposes.
